TotalEnergies EP Uganda (COMPANY) in its capacity as Operator of Contract Area (CA) 1 and License Area (LA) 2, in conjunction with its Joint venture partner(s), invite experienced and reputable service providers to express their interest in provision of medical services as further described below.

Brief description of the scop of services:

The perimeter of this Scope of Service is to cover all medical aspects required directly by COMPANY or by COMPANY Contractors undertaking operations within the Tilenga Project, feeder line and within the Kampala area when applicable.

Minimum requirements for participation in the call for tender.

- Evidence of current registration or in process of being registered and classification as Ugandan Company on the National Supplier Database (NSD) managed by the Petroleum Authority of Uganda (PAU).
- Experience/performance of similar services, products and/or equipment within Uganda, East Africa or internationally.
- Must possess all required licenses required to provide the above services.
- Suitably qualified and experienced personnel.
- Available capacity to provide the services.
- Financial capability to undertake the eventual contract and Cost Per Indicators.
- Health Safety and Environment (HSE) Management system, Quality Policy and related procedures in compliance with local and international standards.
