- URA registration certificate.
- Must be a Ugandan Company or registered entity in Uganda.
- Companies in the Albertine Region are highly encouraged to apply.
- Company MUST be in operation for at least 5 years.
- MUST prove business growth (in terms of employment and turnover) over the last 5 years and show potential for further growth in case of improved Health Safety and Environment
