TotalEnergies EP Uganda Unveils 200 Ugandans to Join the TILENGA Academy







TotalEnergies EP Uganda has unveiled 200 Ugandan youth who have been selected from the Tilenga MOOC to join the Tilenga Academy training program aimed at empowering youth with skills and international certifications to work on the Tilenga project during the production phase.

The selected candidates will receive training for 2.5 years at various locations starting with the Uganda Petroleum Institute in Kigumba (UPIK) followed by international Oil and Gas training centres and hands-on experience

during Tilenga project installation and commissioning.

The courses to be undertaken include Theoretical training in Oil and Gas, Production, Maintenance, as well as Health, Safety and Environment. 31% of the trainees will specialise in Production, 27% in Mechanical Maintenance, 26% in Instrumentation Maintenance, and 16% in Electrical Maintenance.

"National content development is at the heart of operations and underpins our commitment

and to achieving shared prosperity for Uganda and Ugandans because of this great project. When we launched the Tilenga MOOC in 2021, our objective was clear, to ensure that we maximise awareness tion, and participation of Ugandans in the oil and gas sector," said Philippe Groueix, General Manager, allise TotalEnergies EP Uganda. "I am particularly proud to highlight the diversity of the selected trainees," he added.

10-Million Man Hours Without Lost Time Injuries on the Tilenga Project









TotalEnergies EP Uganda has successfully achieved 10-million man hours without Lost Time Injuries (LTI) on the Tilenga Project. This crucial health and safety industry milestone was achieved on January 13th, 2023.

Measurement of LTI is a lagging indicator which is aimed at measuring a company's incidents in the form of past accident statistics. It measures all on-the-job injuries that require a person to stay away from work for more than 24 hours, or which result in death or permanent disability.

"Safety is a core value at TotalEnergies EP Uganda and our achie of 10-million-man hours without injuries is testament to the fact that all our employees and contractors take this value seriously". Said Philippe Groueix, General Manager TotalEnergies EP Uganda.

Safety is of utmost importance in any oil and gas activity, and TotalEnergies EP Uganda is committed to ensuring that all safety measures are in place to protect its employees, facilities, the environment, and the communities in which it operates.

Currently, the Tilenga project employs more than 5,000 people working with TotalEnergies EP Uganda and its contractors both on site and in Kampala. The Company has invested heavily in state-of-the-art technology and equipment, local and international experts for the development of the projects and has put in place strict safety protocols to minimize risks on its sites.

Speaking at the event, Daniyar Orzhanov, Tilenga Project Head of Production said two types of production chemicals will be required for Tilenga field operations: speciality chemicals and generic chemicals. He explained that along with supply of chemicals, associated services for this contract will include logistics and storage, blending and waste management.

Rosette Komugisha, National Content Team Lead TotalEnergies EP Uganda revealed that the 'Supply of Production Chemicals Services' contract will require high safety, reliability, and integrity from the contractor. She said that eligible Ugandan suppliers have opportunity to participate at tier 1 and tier 2 (subcontracts) scopes in production chemicals supply.

Philippe Groueix, General Manager TotalEnergies EP Uganda thanked all guests for attending the Forum. He reiterated that promoting national content is very important to the Company.

TotalEnergies EP Uganda held its Q1 2023 National Content Supplier Development forum on February 9th, 2023, with the objective of educating potential suppliers on the Company requirements, procurement processes, performance standards and lessons from previous processes.

Themed Awareness of potential opportunities for Ugandan participation in the production of chemicals supply and associated services, the Forum attracted over 200 suppliers and expounded on the requirements for 'Supply of Production Chemicals Services' one of the



Historic: Uganda Commences Oil Drilling at The Kingfisher Oil Field



Uganda launched its first oil spudding on January 24, 2023, at the Kingfisher oil field in Kikuube district in an event attended by several stakeholders including representatives from Uganda National Oil Company (UNOC), TotalEnergies EP Uganda, local and national leadership, the media fraternity, and the general public.

The spudding was commissioned by His Excellency Yoweri Kaguta Museveni, the President of Uganda, at an event organized by the China National Offshore Oil

Corporation (CNOOC) Uganda Limited, one of TotalEnergies EP Uganda's Joint Venture Partners. TotalEnergies EP Uganda was represented by a cohort led by its General Manager, Philippe Groueix.

"I want to salute the Oil and Gas partners. Uganda has got companies like TotalEnergies and CNOOC which are stronger in terms of money and experience in the Oil and Gas sector." said President Museveni as he reiterated the government's commitment to using oil and petroleum resources carefully and

sustainably for the economic development of the country.

The president also committed to the development of our oil resources in tandem with solar energy.

The launch marks the beginning of the drilling of close to 400 wells in Lake Albert Rift Basin to produce oil resources.



2023 HSE Contractor Forum Spotlights Measures Taken to Reduce Impacts During Tilenga Project Activities







TotalEnergies EP Uganda hosts annual Health, Safety and Environment (HSE) Contractor Forums to engage with employees and contractors working on the Tilenga Project. The purpose of the forums is to emphasize the importance of collective responsibility and leadership towards safety as a core value at TotalEnergies and within its operations. Themed 'Reduce our impacts during Tilenga project activities', the 2023 Forum was attended by representatives from Petroleum Authority of Uganda, Joint Venture Partners, Contractors and other stakeholders in

Uganda's Oil and Gas sector.

While addressing attendees, Philippe Groueix, General Manager TEPU said it was the responsibility of both management and employees to undertake project work in a safe manner to avoid any fatalities, emphasizing that the Tilenga Project would never be considered a success if it is not delivered safely.

Among the initiatives so far undertaken, 1,336 safer drivers have so far been trained and certified, road safety activities have been

undertaken in 130 schools and 2 (two) million community members have been engaged on safe road usage.

To conclude the event, companies were awarded for demonstrating the Best Health Safety and Environment (HSE) performance 2022 in 3 categories; High Risk Category: Mineral Services Ltd, Medium Risk Category: Technical Masters Ltd and Low Risk Category: ATACAMA Consulting.

Commemorating International Day of Forests







The UN General Assembly proclaimed 21st March the **International Day of Forests** in 2012, with the aim to celebrate and raise awareness of the importance of all types of forests. This year, the day was celebrated under the theme "Healthy Forests for Healthy People".

In the same spirit, TotalEnergies EP Uganda (TEPU) joined the rest of the world to commemorate the day on Tuesday 21st March, through an internal Webinar coordinated by the biodiversity team.

The Webinar started with remarks from Mariam Nampeera Mbowa Deputy General Manager TEPU who reiterated said that forests are the most biologically diverse ecosystems on land, home to more than 80% of the terrestrial species of animals, plants and insects. They also provide health benefits, shelter, jobs and security for forest-dependent communities.

Despite all these priceless ecological, economic, social and health benefits, global deforestation continues at an alarming rate

with 13 million hectares of forest destroyed annually.

The Company's Biodiversity team presented TEPU's work with various stakeholders including the National Forestry Authority (NFA), Private Forest Owners, ECO TRUST and Chimpanzee Trust to protect the forest reserves in the Tilenga project area, restore connectivity linkages between existing forest reserves to restore and enhance wildlife mobility along the Bungoma Bodongo forest corridor, among others.



MUK Emergency Medical Skills Training Centre Construction Project Project Kicks Off



Last year, TotalEnergies EP Uganda signed an MoU with Makerere University to provide capacity building support to the college of Health Sciences towards upgrading the Emergency Medical Skills Training Centre.

In light of this, on 10th March, a project kickoff meeting was held with the respective

stakeholders on the project; TEPU, the Training Center management team, and the implementing Contractor. The purpose of the meeting was to initiate the implementation of a 5-6-week project whose main goal will be to facilitate training of emergency medicine physician specialists and paramedics.

This support includes funding of the center's fit-out works, supply of medical training equipment, simulation medical equipment to be utilized during the emergency medical training sessions, lecture / communication aid, and it will fully be operated by the Makerere University College of Health Sciences.

Cash Compensation transforms Fuacan's livelihood



An idea that started small after receiving cash compensation has turned out to be a gold mine for Emily Fuacan, 52, one of the Resettlement Action Programme one-to-five (RAP 2-5) Project Affected Persons (PAPs) in Buliisa district, who is making making millions from spreading the sweetness of honey everywhere.

Fuacan says she received a Shs 25m cash

compensation for crops and other properties impacted by Tilenga Project, which she used part of it to acquire more beehives. The enterprise now fetches the 52-year-old sh2.5 million per year from the sale of honey and its products. Her main customers are oil and gas companies such as MSL, a company offering catering services to TotalEnergies, which buys on average five litres of honey per week.

Fuacan, also acquired two plots of land in Nebbi district and another plot in Biiso in Masindi district.

"I am a very strong believer and all along I have been asking God to give me money to acquire land, start a business, and I think God listened to my prayers that's why TotalEnergies came," says Fuacan.



A Welder Taking on The Sky



Dez Liz Habwahangwire is a 29-year-old mother of two. While pursuing a bachelor's degree in Education at Makerere University, she took time off to raise her new-born baby.

It was during this short break that she came across a TotalEnergies EP Uganda (TEPU) advertisement calling for youth under the age of 20 to apply for a skilling course in welding. Dez Liz applied and was admitted for the second cohort of the vocational skilling and

training program.

She enrolled for a three-month coded welding training conducted by e360 and iosh on behalf of TotalEnergies EP Uganda and graduated in October 2019, using her newly acquired skills to get a job at SBC as a Safety Patrol Officer under Hot Works Department at the Hoima Airport construction site where her career continued to grow.

The 29-year-old now owns a restaurant in

Kikuube District, is a District Youth Councillor and is an aspiring pilot. She hopes for financial support from well-wishers to achieve her dreams.

"I thank God every day for He has made my journey complete. I somehow find my steps when I am stuck and I am very grateful to TotalEnergies because they supported my first step which was the welding training," a smiling Dez Liz remarks.



Enhancing Livelihoods Through Skilling Initiatives: A Beneficiary's Story



Abikuha Mildred, did not know what the future held when she was told her home for all her adult life would be razed to allow for the construction of the Central Processing Facility (CPF), the heartbeat of the Tilenga Project. Both Mildred and her mother were affected under RAP 1 which covered the construction of the Industrial Area that would host the CPF, the Construction Camp, Drilling Support Base, amongst several other key installations.

As a land user, Mildred was paid compensation for her crops on the land in Kasenyi and she has used that money to pay school fees for her 3 children. She was also selected

amongst the Project Affected Persons (PAPs) to undergo skills training and was enrolled for a catering course at Millennium Business School in Hoima District. Equipped with a certificate of completion and new skills acquired over the 6-month training period, Mildred immediately applied for a job with Mineral Services Limited (MSL) and got work as a housekeeper in Bugungu Camp.

Mildred was also later affected under RAP 5 which covers the construction of access roads in Kasenyi. Her home was again one of the properties that had to make way for construction of access roads leading to the

Industrial Area. She has already been paid her compensation and has used that money to buy a small piece of land. She also explained "I recently got a phone call informing me that I am one of the PAPs who has been selected under RAP 5 to undergo skills training. Since I was initially trained in catering, I have asked to be trained in driving skills and I am now waiting for official communication on when we shall start."

Mildred is so far content with what the Tilenga Project has added to her life despite her initial fears, and she is grateful for the positive impact the project has had on her family.

Promoting Culture to Improve Livelihoods





 Stakeholders have been engaged through radio announcements and podcasts (focusing on employment fraud, movement of key Tilenga project equipment, unreachable project affected persons (PAPs) under Resettlement Action Plans 2-5, road safety and grievance management).



Implementation of Contractor Social Management Plans and Labour Management Plans:

- Offering support to contractors to undertake community recruitment within the Tilenga project area using the ballot box critera.
- 1559 people (239 female and 1320 male) were employed in 2022


