# "BALL KIDS BY TOTALENERGIES" CONTEST RULES

#### CLAUSE 1. CONTEST ORGANISER

"Ball Kids by TotalEnergies" is a contest (the "Contest") organised, in the name and on behalf of the Affiliates listed in Appendix 2 (hereinafter said Affiliates will be collectively referred to as the "Organisers" and individually as an "Organiser"), by Total Marketing Services, a French société par actions simplifiée (simplified limited company) whose registered office is located at 24 Cour Michelet, 92800 Puteaux, France, and which is registered under number 542 034 921 (Nanterre Trade and Companies Register), acting in the name and on behalf of the Organisers.

The Contest will be set up and promoted in the Organisers' network of TotalEnergies service stations in Africa in connection with the TotalEnergies Africa Cup of Nations Cameroon 2021 football competition, which will take place from 9 January 2022 to 6 February 2022.

The Contest is operated by the Organisers within the countries where they are respectively registered (hereinafter the "Participating Countries", as listed in Appendix 1 to these Rules), under their sole responsibility within such country.

For the purposes of these Rules, the term "Affiliate" means, in relation to TotalEnergies SE, all companies that are directly or indirectly Controlled by TotalEnergies SE (the term "Control" means directly or indirectly holding more than 50% of the voting rights; the terms "Controlled", "To Control" and "Controlling" are interpreted accordingly).

## CLAUSE 2. PURPOSE OF THE RULES

These rules (hereinafter the "Rules"), consisting of this document and its appendices, set out the terms and conditions governing participation in the Contest and the terms and conditions governing the operation of the Contest.

Each Organiser organises the Contest in its own name and on its own behalf in the relevant Participating Country. There is no joint and several liability between the Organisers in the various Participating Countries.

Within each Participating Country, the Organiser registered in the Participating Country is solely liable to the Participants who have participated in the network of TotalEnergies service stations located in the relevant Organiser's country.

# CLAUSE 3. DESCRIPTION OF THE CONTEST

TotalEnergies offers to take the youngest fans to the heart of African football by offering them the opportunity to become "Ball Kids by TotalEnergies" during the TotalEnergies AFCON Cameroon 2021 football competition.

Through participation in an in-station contest open exclusively to children who are between the ages of 13 and 16 years on the starting date of the Contest, each Organiser in a country qualified for the competition will select one child to be a ball kid at a match of the TotalEnergies AFCON Cameroon 2021.

The dates of the matches to which the Ball Kids by TotalEnergies will be invited are currently being selected and will be announced at a later date.

## CLAUSE 4. DURATION OF THE CONTEST

The Contest will begin on 1 September 2021 at 8.00 A.M (morning) and will end on 30 September 2021 at 8.00 P.M (at night).

#### CLAUSE 5. PARTICIPATION REQUIREMENTS

- **5.1.** Participation in the Contest will be deemed unreserved acceptance of these Rules in their entirety, as well as the ethical rules and the statutes, regulations and other laws in force in the country in which participation takes place. Non-compliance with the participation requirements set out in these rules will invalidate the relevant participation.
- 5.2. Participation in the Contest is limited to individuals who meet all of the conditions below at the starting date of the Contest (hereinafter the "**Participant**"). Participants must:
  - Be between 13 and 16 years old.
  - Live in Africa.
  - Hold a valid visa and passport during the TotalEnergies AFCON competition, which will take place from 9 January 2022 to 6 February 2022, in order to be able to travel to Cameroon, the host country of the competition, if the child lives in another African country.
  - The child's legal guardian must have the power to represent the child and shall accompany him/her
    if he/she is selected to participate as a Ball Kids by TotalEnergies in one of the matches of the
    TotalEnergies AFCON Cameroon 2021.
  - The child's legal guardian must hold a valid visa and passport during the TotalEnergies AFCON Cameroon 2021 competition, which will take place from 9 January 2022 to 6 February 2022, in order to be able to travel to Cameroon, the host country of the competition, if the child lives in another African country.
  - The child's legal guardian must have a personal email address at which he/she can be contacted, if necessary, for the requirements of administering the Contest.
- 5.3. Employees of the Organisers, as well as persons who have participated, directly or indirectly and in any capacity, in the preparation of the Contest, in particular persons who work for the Organisers, as well as members of their families, are not eligible to participate in the Contest.
- 5.4. Only entries that comply with all provisions of the Rules will be accepted. Consequently, the Organisers reserve the right to make all necessary verifications of each Participant's identity, age and contact details. Any incomplete, erroneous or falsified information, or information that does not allow the Participant to be identified or located, will result in the cancellation of his/her entry.
- 5.5. It is strictly forbidden for Participants to play using more than one email address or to play from a player account opened for another person. A maximum of one entry per child is allowed (same first name and last name, same postal address).
- 5.6. It is strictly prohibited to modify or to attempt to modify, by any means, the Contest's procedures, in particular in order to change the results.

## CLAUSE 6. HOW TO PARTICIPATE IN THE CONTEST

To participate in the Contest, Participants must:

- Step 1: complete an entry form, in paper format, which is available at participating TotalEnergies service stations:
  - The front of the form includes a space for a drawing of the Participant, who is invited to draw a picture illustrating a significant moment in his/her life or one of his/her dreams in connection with his/her passion for football.
  - The back of the form includes a space for entering the personal details of the Participant and his/her legal guardian, which must be provided in order to validate his/her entry in the Contest.

Note: In the case of Total Ethiopia, participants shall collect the form from all Total stations in Addis Ababa (printed form) or download the form from Total Ethiopia website page <a href="https://totalenergies.et/totalenergies-afcon">https://totalenergies.et/totalenergies-afcon</a> and print.

- Step 2: validate their entry in the Contest, which is done solely by submitting the entry form in one of the following ways:
  - Depositing the form in the box provided for this purpose in the participating TotalEnergies service stations of the Organiser in the country in which the entry is made; or
  - Sending the form by post to the address of the Organiser's registered office in the country in which the entry is made.

Note: In the case of Total Ethiopia, the contestant shall submit the form in the selected four (4) service stations that are located in Addis Ababa, which are Mexico Total, Bole Road Total, Arat Kilo Total and Lamberet Total or send the form by post to the address "1462, Total Ethiopia Head Office, Addis Ababa, Ethiopia".

Participation in the Contest is allowed only in accordance with the above procedure. Participation in any other form or by any other means will not be taken into account.

The Personal Information the Participant provides must be valid and truthful; otherwise, he/she will be excluded from the Contest and, if applicable, will be deprived of his/her status as winner.

In particular, the following non-exhaustive list of content will be rejected automatically, i.e. content that:

- is vulgar, pornographic, racist, paedophiliac or harmful to minors;
- is defamatory, insulting or slanderous to third parties, whether individuals or legal entities;
- is political in nature and/or deemed sensitive by the Organiser;
- infringes on the privacy or image rights of third parties and/or violates applicable laws; or
- is contrary to good morals and/or public policy.

Similarly, Participants undertake to comply with the intellectual property rules in force and, therefore, not to reproduce, display, distribute or modify, in any manner, any content (signs, writings, images or messages of any type) for which they have not obtained the express authorisation of the rights-holders at the time of their entry.

It is strictly prohibited to modify or to attempt to modify, by any means whatsoever, the Contest's procedures, in particular in order to change the results or to influence by an automated or unfair means the validity of the designation of a Winner. If a Participant is found to have won in breach of these Rules or by fraudulent means, the prize will not be awarded to him/her, without prejudice to any proceedings that may be initiated against the Participant by the Organiser or by third parties.

# CLAUSE 7. PROCEDURES FOR CHOOSING AND INFORMING WINNERS

7.1. At the conclusion of the Contest, i.e. on 30 September 2021, each Organiser will centralise and process the entries.

- 7.2. Within 15 days from the conclusion of the Contest, i.e. from 1 October 2021 to 15 October 2021, a local jury set up within each Organiser will select the five (5) best drawings that meet the selection criteria listed in Clause 3 from among all drawings submitted.
- 7.3. In order to verify the accuracy of the information of the five (5) Participants selected by each Organiser in its country, each Organiser may contact the selected Participants by telephone or email before 15 October 2021.

If the Organiser does not receive a reply from the Participant within five (5) calendar days, his/her place among the five (5) Participants selected by the Organiser will be automatically awarded to another Participant.

- 7.4. The five (5) best drawings selected by the Organisers will be forwarded to Total Marketing Services during the third week of October 2021, i.e. from 16 October 2021 to 22 October 2021, for a final selection of drawings.
- 7.5. Upon receipt of all drawings forwarded by the Organisers to Total Marketing Services, a jury set up by Total Marketing Services will select one drawing per Organiser. This selection will be made between 23 October 2021 and 29 October 2021.

Total Marketing Services will select a total of 19 drawings, one (1) per Organiser.

- 7.6. When the final selection has been made, on 29 October 2021, Total Marketing Services will advise each Organiser of the Winner to be contacted in order to inform him/her that he/she has been chosen to participate in the TotalEnergies AFCON Cameroon 2021 as a Ball Kid by TotalEnergies.
- 7.7. Thereafter, no later than seven (7) business days after 29 October 2021, each Organiser will inform the Winner in its country. No later than seven (7) calendar days after receiving an email and telephone call, the Winner who has been contacted must confirm his/her participation by returning the confirmation form to the Organiser in order to attend the TotalEnergies AFCON Cameroon 2021 match at which he/she will be invited to participate as a Ball Kid by TotalEnergies.
- 7.8. If the Winner fails to respond to the Organiser in his/her country in the manner and within the deadline above, he/she will forfeit his/her place as a Ball Kid by TotalEnergies. For the avoidance of doubt, it is hereby specified that Participants who have not been selected will not be contacted.

# CLAUSE 8. ISSUANCE AND USE OF THE PRIZE

# 8.1. Issuance and use of the prize

Each Winner will receive, at his/her postal address, a document from the Organiser of his/her country confirming his/her participation and the match at which he/she is invited to be a Ball Kid by TotalEnergies during the TotalEnergies AFCON Cameroon 2021.

Between 29 October 2021 and 6 January 2022, the Organiser will contact the legal guardians of the Winners who have confirmed their attendance in order to provide them with the necessary information on the event and the dates of attendance at the matches of the TotalEnergies AFCON Cameroon 2021.

# 8.2. Additional information on use of the prize

No Winner shall in any manner dispute any Ball Kids by TotalEnergies prize awarded. Each prize awarded is strictly personal and shall not be transferred or sold to any third party. Furthermore, the Organiser will not provide any cash refund, make any exchange or remit the equivalent value thereof, in whole or in part, in kind or in cash.

#### CLAUSE 9. ADVERTISING AND PROMOTION OF WINNERS

Solely by virtue of allowing his/her child to become a Ball Kid by TotalEnergies, unless he/she expressly objects, the Winner's legal guardian authorises the Organiser of his/her country to use the Winner's first and last names, as well as, potentially, the Winner's city of residence, in any medium, in particular any electronic medium, for the purpose of any advertising or promotional event in connection with the Contest, in Africa, Madagascar, Mayotte, Reunion Island, Mauritius + islands, as well as in mainland France, from the announcement of his/her participation until the expiry of a period of six (6) months from such date, without conferring on him/her any right to remuneration or any other benefit other than being a Ball Kid by TotalEnergies.

If the Winner's legal representative objects, he/she must state this in a letter sent to the following address: Ballkids.Ethiopia@totalenergies.et.

#### CLAUSE 10. ACCESS TO THE RULES

The Rules can be viewed, downloaded and printed online from the following link <a href="https://totalenergies.et/totalenergies-afcon">https://totalenergies.et/totalenergies-afcon</a> throughout the duration of the Contest.

A copy of the Rules will also be sent, by post, to any person who sends a written request therefor on ordinary paper to the Contest address, and legibly provides his/her full contact details (first and last name, postal address), no later than ten (10) business days before the end date of the Contest (as evidenced by the postmark).

In any event, any incomplete or illegible request, any request sent to an address other than the address specified above or any request sent after the expiry of the above deadline (as evidenced by the postmark) will be deemed void.

In the event the Contest is extended or postponed, the deadline for submitting requests for the Rules will be prolonged accordingly.

## CLAUSE 11. CHANGES, SUSPENSION OR CANCELLATION

The Organiser shall not be liable if, due to a force majeure event or events beyond its control, the Contest is cancelled, postponed, suspended, modified or shortened. In any event, the Organiser reserves the right to extend the participation period, and to postpone any date and/or time announced. The Organiser reserves the right to make changes to the Rules during the period of the Contest. Any changes will be reflected in an amendment to the Rules published in <a href="https://totalenergies.et/totalenergies-afcon">https://totalenergies.et/totalenergies-afcon</a> and filed with Total Ethiopia S.C. Amendments will take effect upon publication.

Participants will be deemed to have accepted such changes simply by participating in the Contest after the date on which the change takes effect, and they expressly waive the right to make any claim or challenge with respect to any change the Organiser makes to the Rules.

The Organiser may cancel all or any part of the Contest if it appears that fraud has occurred in any manner in connection with the participation in the Contest.

#### CLAUSE 12. USE OF PARTICIPANTS' PERSONAL DATA

#### 12.1. Data collection

Information about Participants will be processed by the Organiser in connection with their participation in the Contest.

Personal data collected during registration for the Contest (hereinafter "**Personal Data**") will be processed for the purposes of conducting the Contest and ranking Participants.

The Organiser will also process Personal Data for sales prospecting purposes (sending communications or sales offers), subject to Participants' consent. Each Participant may withdraw his/her consent to receive such communications and sales offers at any time using the methods described in each message. The Organiser will collect and process Personal Data in accordance with the laws of the country where it is registered.

#### 12.2. Data recipients

The Organiser may disclose Personal Data collected from Participants to certain departments of the Organiser, as well as to IT service providers and subcontractors acting on behalf of the Organiser, solely for the performance of their tasks carried out for the purposes of the organisation and proper operation of the Contest.

The Organiser may transmit the Personal Data collected in the event a request is received from a judicial authority or any administrative authority authorised by law requesting the production of such Personal Data, in accordance with the statutes and regulations in force in the country where the form was submitted.

# 12.3. Data transfers

Any transfer of Personal Data to a third country outside the European Economic Area will be carried out in accordance with applicable laws and in a manner that ensures adequate data protection.

Binding Corporate Rules (BCR) have been adopted to ensure adequate protection of Personal Data that originates in the European Economic Area and that may be transferred to Total Group entities established outside the European Economic Area. For transfers of Personal Data that are not covered by the BCR and are made to countries outside the European Economic Area, other measures are put in place to ensure adequate protection of Personal Data. For information on the other measures put in place to ensure adequate protection, please write to the contact address provided below.

#### 12.4. Security and confidentiality of Personal Data

The Organiser has implemented appropriate measures to ensure the security and confidentiality of Personal Data and, in particular, to prevent Personal Data from being altered or damaged and to prevent access thereto by unauthorised third parties, in compliance with applicable statutes and regulations.

#### 12.5. Retention of Personal Data

The Organiser will keep the Personal Data for the entire duration of the Contest in order to ensure the proper operation thereof, i.e. until 6 February 2022. If necessary, the Personal Data may be kept in interim archives for the applicable statutory period of prescription.

# 12.6. Rights of Participants

In accordance with the laws in force, Participants are entitled to access, rectify and request the deletion of their Personal Data, and may also request that processing be limited. Participants also have a right to data portability and may object to processing, including for sales prospecting purposes. Participants may also withdraw their consent at any time if processing is carried out on this legal basis.

To exercise their rights and or request information about the processing of their Personal Data, Participants may submit a request to the address provided in the personal data policy on the Organiser's Site.

If, after having contacted the Organiser, Participants believe that their rights have not been respected, they may submit a complaint to the competent supervisory authority.

#### CLAUSE 13. INTELLECTUAL PROPERTY - IMAGE RIGHTS

- 13.1. All names or trademarks referred to in these Rules, as well as in any communication materials relating to the Contest, are the sole property of the parties that create or register them.
- 13.2. The images and videos used, the objects represented, the trademarks and trade names mentioned, the graphic and computer elements, and the databases are the sole property of the respective owners thereof and shall not be extracted, reproduced or used without their written authorisation. Violators are subject to civil and/or criminal prosecution.
- 13.3. The reproduction, display or use of the communication elements, in whole or in part, by the Participants without the Organiser's prior authorisation is strictly prohibited.
- 13.4. Any resemblance of the characters or elements of the Contest to other fictional characters or other elements already in existence is purely fortuitous and will not cause the Organiser or its service providers to incur liability.
- 13.5. From the beginning of the Contest on 1 September 2021 to the end of the TotalEnergies AFCON competition on 6 February 2022, the Organiser shall be entitled to make a video recording that may require the presence of the future Ball Kid by TotalEnergies.

By confirming his/her participation, the Participant's legal guardian authorises the assignment of the Participant's image rights in connection with the video recording/photos made by the Organiser.

## **CLAUSE 14. LIABILITY**

- 14.1. The Organiser shall not be liable for any damage of any type (personal damage, physical injury, property damage, financial loss, etc.) caused by a Participant's entry in the Contest. The Participant's entry in the Contest will be deemed acceptance of this condition. No claim will be accepted on these grounds.
- 14.2. The Organiser undertakes to implement the necessary health protocol measures to protect the health of the Winners (COVID screening tests to be presented prior to arrival, on-site tests, providing hand sanitising gels and surgical masks, raising awareness of social distancing measures to prevent the spread of COVID). The Organiser may cancel all or any part of the Contest if it is clear that the health situation at the time of the TotalEnergies AFCON Cameroon 2021 matches involving the Ball Kids by TotalEnergies does not allow participants to attend under safe health conditions.
- 14.3. The Organiser may cancel all or any part of the Contest if it appears that fraudulent actions have occurred in any manner. In such case, the Organiser reserves the right not to award the prize to

the fraudsters and/or to initiate legal action against the perpetrators of such frauds before the competent courts.

- 14.4. The Organiser will use its best endeavours to enable access at all times to the participating service stations of the TotalEnergies network in its country, but shall have no obligation to succeed in doing so. The Organiser may interrupt the Contest at any time, in particular for technical reasons or to perform updating or maintenance. The Organiser shall in no event be liable for such interruptions and the consequences thereof.
- 14.5. The Organiser shall in no event be liable if the personal details relating to a Participant's registration do not reach it for any reason for which it is not responsible, including, but not limited to, if the information on the form it receives is illegible.
- 14.6. The Organiser shall in no event be liable for any loss of data or damage to the Participant's Personal Data.

#### CLAUSE 15. EXCLUSION RIGHT

The Organiser may, automatically and without prior notice, exclude any Participant who does not comply with the Rules, as well as to cancel outright any winnings to which said Participant may be entitled.

Furthermore, the Organiser may, automatically and without prior notice, delete and cancel any entry to the Contest that contains obvious errors concerning the identity and age of a Participant.

The Participant also acknowledges the Organiser's right to delete and cancel the entry to the Contest of any Participant who has created or used a method aimed at winning the prize in an unfair and/or unusual manner. Such cancellation may occur at any time and without prior notice. No claim will be accepted on these grounds.

## **CLAUSE 16. EVIDENTIARY AGREEMENT**

It is agreed that, except in the event of manifest error, the Organiser may assert, in particular for purposes of proof, any act, fact or omission, or any program, data, file, recording, operation or other element (such as follow-up or other reports), of any type, including in computer or electronic formats or media, established, collected or stored directly or indirectly by it, in particular in its information systems.

Therefore, such elements will constitute proof and, if they are produced as evidence by the Organiser in any litigation or other proceedings, they will be admissible, valid and enforceable between the parties in the same manner, under the same conditions and with the same probative force as any document that may be established, collected or stored in writing.

# **CLAUSE 17. COMPLAINTS**

However, the Organiser reserves the right not to respond to any complaints it deems inappropriate.

# **CLAUSE 18. ETHICS**

18.1. The Organiser hereby stresses its commitment to comply with the rules on preventing corruption, fraud and violations of the competition laws and that it expects each Participant to respect this same commitment.

18.2. Furthermore, each Participant shall report any potential conflict of interest that may arise during his/her participation in the Contest, in particular due to the existence of any family, business or other relationship that may create suspicion regarding his/her participation.

#### **CLAUSE 19. INDEPENDENT PARTIES**

Registration and participation in the Game in no event creates a relationship of subordination between the Organiser and the Participant.

#### CLAUSE 20. GOVERNING LAW - JURISDICTION

- 20.1. These Rules are governed exclusively by the law of the Participating Country where the Organiser is registered, to the exclusion of its conflict of laws principles.
- 20.2. Any dispute that may arise in connection with the Contest shall be submitted to the competent courts, in view of the nature of the dispute, in the city where the Organiser is registered, as specified in Appendix 2.

#### CLAUSE 21. ENTIRE DOCUMENT - INVALIDITY

In the event any provision of these Rules is invalidated due to a change in the statutes or regulations or due to a court decision, the validity of, and the obligation to comply with, the other provisions of the Rules will in no way be impacted thereby.

# CLAUSE 22. FILING OF THE RULES

These Rules are filed with Total Ethiopia S.C whose offices are located at Debrezeit road - Mullege Building (7th Floor), and will be sent, free of charge, to any person who requests them by writing to the following address: Ballkids.Ethiopia@totalenergies.et
