

EXPRESSION OF INTEREST FOR THE PROVISION OF MONITORING AND EVALUATION SERVICES UNDER THE TILENGA PROJECT IN UGANDA

TotalEnergies EP Uganda (COMPANY) as Operator of Contract Area (CA) 1 and License Area (LA) 2 North, in conjunction with its Joint Venture Partners, invites experienced and reputable companies to express interest in providing Monitoring and Evaluation (M&E) services for social programmes being implemented in Buliisa, Nwoya, Kikuube, Pakwach and Hoima Districts in the Albertine region of Uganda. These activities will be implemented as part of the Project's impact management initiatives.

General Field Development Description:

The Tilenga oil and associated gas development (Project) is in the North East area of Lake Albert in Uganda and covers the fields in CA-1 block and the Northern part of LA-2 block. The facilities include wellpads (31), an industrial area containing the Central Processing Facility (CPF) and associated supporting infrastructure (camps, roads etc).

The Monitoring and Evaluation Services for the Social Programmes Will Include the Following:

- Review Social Management Plans and resulting programmes to assess the logic of activities, and performance indicators. Document strengths, gaps, and recommendations for improvement.
- Deliver a monitoring and evaluation alignment workshop.
- In collaboration with TEP Uganda teams, improve or develop, when appropriate, the monitoring and evaluation framework of specific social management plans and/or component programmes (including inputs, activities, outputs, outcomes, impact targets & progress against the theory of change). The consultant will use problem and solution trees, logical framework, and or other appropriate tools to develop/focus on key indicators and targets with TEP Uganda teams.
- The Consultant must use a participatory approach through the process.
- Review and update or develop the Monitoring, Evaluation and Reporting plan for specific social management plans and/or component programmes.

- Implement monitoring and evaluation activities for specific social management plans and/or component programmes.
- Provide recommendations for TEP Uganda to improve systematic supervision of the contracted third parties delivering Social Management Plans and/or component programmes.

Minimum Requirements:

- At least a minimum of 5 years of work experience in related field works i.e. multi-disciplinary capacity on monitoring and evaluation, with a track record and working knowledge in social development in Uganda.
- Experience working with the World Bank and / or other international development organizations will be beneficial.
- Experience in identification and assessment of a range of approaches to data collection (i.e. survey methods and design), implementation and analysis in environmental and socio-economic fields.
- Experience of work with local communities through participatory approach.
- Proof of successful accomplishment of similar services in Uganda-experience, & recognition for M&E activities for International Finance Corporation (IFC) or World Bank funded projects is desirable.
- Current registration to, or application to be registered to; the Petroleum National Supplier Database.
- Be registered with NSSF and with all required insurances for the vendor and its employees.
- Compliance with National Content Regulations and 2016 Upstream Petroleum Regulations.
- Compliance to national and international laws and oil and gas international standards.
- Must have an appropriate HSE Management system, Quality Policy and related procedures in compliance with local and international standards.
