EXPRESSION OF INTEREST FOR THE PROVISION OF AGRICULTURE DEVELOPMENT PROGRAM-PHASE III UNDER THE TILENGA PROJECT IN UGANDA REFERENCE: 10359879

TotalEnergies EP Uganda (COMPANY) as Operator of Contract Area (CA)1 and License Area (LA) 2 North, in conjunction with its Joint Venture Partners, invites experienced and reputable companies to express interest in providing Agriculture Development Program-Phase III covering Villages in Buliisa, Nwoya, Kikuube, Pakwach and Hoima Districts in the Albertine Graben Region of the Republic of Uganda. These activities will be implemented as part of the Project's impact mitigation initiatives.

General Field Development Description:

The Tilenga oil and associated gas development (Project) is in the North-East area of Lake Albert in Uganda and covers the fields in CA-1 block and the Northern part of LA-2 block. The facilities include well pads (30+), an industrial area containing the Central Processing Facility (CPF) and associated supporting infrastructure (camps, roads etc.).

Scope of Work

The Agriculture Development Program will include, but not be limited to, the following:

- Provide inputs, introduction of new input varieties extension support (Staple crops (cassava, maize, rice), field and horticultural crops as appropriate to demand) to increase production and productivity.
- Establish trading relationships between farmer groups and local, regional and national-level markets.
- Increase the capacity of farmers and farmer organizations to

meet market demand requirements of quality, quantity, while reducing post-harvest losses.

- Establish, equip and operationalize or improve existing aggregation centers and or value addition facilities.
- Establish synergies with other agribusiness value chain actors in the region and ensure sustainability of interventions made.
- Develop the financial and management capacity of farmer groups and link them to financial service providers.

Minimum requirements:

- At least 5 years of providing similar services in Uganda.
- Current registration to, or application to be registered to, the Petroleum National Supplier Database
- Compliance with National Content Regulations and 2016 Upstream Petroleum Regulations.
- Must have suitable, qualified employees and experienced in provision of the above said services.
- Be registered with NSSF and with all required insurances for the vendor and its employees.
- Adequate financial capacity to undertake the eventual contract.
- Compliance to national and international laws, and oil and gas international standards
- Must have an appropriate HSE Management system, Quality Policy and related procedures in compliance with local and international standards.
