Announcement of the Final Investment Decision brings Uganda closer to first oil

uring a ceremony held on 1st February, 2022 in Kampala, in the presence of Yoweri Museveni, President of the Republic of Uganda, Philip Mpango, Vice-President of the United Republic of Tanzania, Patrick Pouyanné, Chairman and CEO of TotalEnergies, and representatives of the China National Offshore Oil Corporation (CNOOC), the Uganda National Oil Company (UNOC) and the Tanzania Petroleum Development Corporation (TPDC), the Lake Albert Development Project partners announced the final investment decision and the launch of this major project representing a total investment of approximately \$10 billion.

The Lake Albert development encompasses the Tilenga and Kingfisher upstream oil projects in Uganda and the construction of the East African Crude Oil Pipeline (EACOP) in Uganda and Tanzania. The Tilenga project, operated by TotalEnergies, and the Kingfisher project, operated by CNOOC, are expected to start producing in 2025 and to reach a cumulative plateau production of 230,000 barrels per day.

The upstream partners are TotalEnergies (56.67%), CNOOC (28.33%) and UNOC (15%). Production from the oil fields in Uganda will be transported to the port of Tanga in Tanzania through the EACOP cross-border pipeline, whose shareholders are TotalEnergies (62%), UNOC (15%), TPDC (15%) and CNOOC (8%).

"This officially marks the beginning of the detailed Engineering, Procurement and Construction (EPC) phase by the Joint Venture Partners and, therefore, a commitment to see first oil by 2025, a journey that started in 2006. It is during this phase that we expect Ugandans to accrue significant benefits and opportunities from the sector through local content."

The upstream partners are TotalEnergies (56.67%), CNOOC (28.33%) and UNOC (15%). Production from the oil fields in Uganda will be transported to the port of Tanga in Tanzania through the EACOP cross-border pipeline, whose shareholders are TotalEnergies (62%), UNOC (15%), TPDC (15%) and CNOOC (8%).

Dr. Ruth Nankabirwa Ssentamu, Minister for Energy and Mineral Development.

All partners are committed to implementing these projects in an exemplary manner, taking into consideration the environmental and biodiversity stakes, as well as the rights of the concerned communities, in accordance with the stringent performance standards of the International Finance Corporation (IFC). In this context, the land acquisition program is currently underway, incorporating areas of improvement identified by independent third-party reviews performed after the first phase of this program led in 2018-2019.

Furthermore, TotalEnergies is committed to implementing action plans that will have a net positive impact on biodiversity as part of the implementation of these projects. In close liaison with the authorities and stakeholders concerned with nature conservation in Uganda and Tanzania, these action plans will be implemented in collaboration with neighboring communities and under the supervision of an independent institution.

"The development of Lake Albert resources is a major project for Uganda and Tanzania, and our ambition is to make it an exemplary project in terms of shared prosperity and sustainable development. We are fully aware of the important social and environmental challenges it represents. We will pay particular attention to use local skills, to develop them through training programs, to



boost the local industrial sector in order to maximize the positive local return of this project," said Patrick Pouyanné, chairman and CEO of TotalEnergies. "With today's signing of a framework agreement on renewable energy, we are laying the foundation to implement our multi-energy strategy in Uganda and contribute to people's access to energy.

This oil development is in line with TotalEnergies' strategy of only approving new projects if they are low-cost and low emissions. In particular, the design of the facilities incorporates several measures to limit greenhouse gas emissions well below 20 kg CO2eq/boe, including the extraction of Liquefied Petroleum Gas for use in regional markets as a substitute for burning biomass, and the solarization of the EACOP pipeline.

"Today is a historic day for TotalEnergies EP Uganda. This Final Investment Decision materializes after more than 6 years of intense effort from all our teams in close coordination with the Government of Uganda. It is a moment of great satisfaction and excitement which also comes with the responsibility to deliver, together with our partners these projects on time and in compliance with the highest standards, while ensuring sustainable value retention in the economy through promotion of national content. The journey ahead of us is still long but we are, more than ever, fully committed to make it a great success for all, working together with our stakeholders.", Mr. Philippe Groueix, General Manager TotalEnergies EP Uganda.

TotalEnergies and the Ugandan Ministry of Energy and Minerals also signed a Memorandum of Understanding (MoU) for the development of renewable energy with the objectives of developing 1 GW of installed capacity, promoting access to electricity and clean energy, supporting national climate change objectives through the deployment of carbon footprint reduction projects.



UNBS OFFICIALS VISIT TILENGA PROJECT

delegation of ten officials from the Uganda National Bureau of Standards (UNBS) visited Tilenga project area on 22nd January 2022 on a familiarization tour of the key sites.

The UNBS team which comprised of: Mrs. Leatitiah Namubiru Manager Legal Metrology, Mr. Hassan Walusimbi Manager Legal , Mr. Deus Mubanguzi Manager Metrology Laboratory, Mr. Mukisa Jackson Head Weights and measures, and others were on a bench-marking tour of the Albertine graben to plan for placement of multiproduct metering points when Uganda starts to produce oil.

Accompanied by TotalEnergies EP Uganda and Petroleum Authority of Uganda (PAU) staff the visiting delegation toured the Industrial area where the Central Processing facility (CPF) will be constructed, resettlement houses for project affected persons (PAPs), The Kirama Water project and Avogera Heath Centre III where TotalEnergies EP Uganda constructed an Out-Patient Department (OPD) house.



TotalEnergies partially hands over construction support base- b to EPSCC contractor for Tilenga project.

On Thursday February 24th, 2022, TotalEnergies EP Uganda partially handed over the Construction Support Base- b (CSB-b) to McDermott, the Engineering Procurement Supply Construction and Commissioning (EPSCC) Contractor for the Tilenga project.

The partial handover of the base was done by TotalEnergies EP Uganda Construction Manager and witnessed by a team of officials from EPSCC contractor and the earthworks contractor Mota-Engil-Uganda. The base will be used to store construction materials for the project.

Other bases that have been handed over to the EPSCC contractor in the recent past, include Construction Camp-a (CC-a); currently under construction, part of Construction Camp-b (CC-b), with the Drilling Support Base (DSB), Central Processing Facility (CPF) still under construction and Operations Support Base (OBS) for those who will operate the CPF remaining.

The completion of the enabling earthworks is expected in July 2022. The camp is planned to house 4,000 persons at peak.







TotalEnergies EP Uganda support boosts RAP1 farmers' potential in Buliisa District



Beropamungu, 34, a resident of Kisomero, Ngwedo sub-county is one of the Resettlement Action Plan 1 (RAPI) Project Affected Persons (PAPs) earning from vegetable growing. He began two-years ago with cotton but after realizing the intensity of labor and land it requires, he decided to concentrate on vegetables. "This has paid off, I earn between three million to four million shillings in a season," said Beropamungu. Beropamungu grows amaranth, eggplants, cabbages, tomatoes, okra, watermelon. "In total, I do seven enterprises on an acre piece of land including Apiary that has about 10 beehives," he reveals.

He attributes his conviction to venture into vegetable growing to TotalEnergies EP Uganda through its contractor Community Integrated Development Iniatives
"I started with half-an-acre piece
of land after getting support from
TotalEnergies EP Uganda through
CIDI. The first harvest wasn't
bad, I was able to get SHS Im
from the different enterprise," He
opines. To Beropamungu, growing
vegetables has an edge over
other crops because it doesn't
require large piece of land and
it matures within a short period
of time, therefore bringing quick
income.

Recently he received mechanized irrigation equipment that has enabled him to farm throughout the year. There are over 100 PAPs vegetables farmers under Resettlement Action Plan 1(RAP 1) in Buliisa district being supported by TotalEnergies EP Uganda.



TotalEnergies EP Uganda Tilenga Massive open online course (MOOC) a success



n 10th January, 2022
TotalEnergies EP Uganda
launched a free online program
dubbed the Tilenga MOOC
(Tilenga Massive Open Online
Course) as part of its commitment to National
Content Development in Uganda.

The program which was aimed at identifying, recruiting, training and developing 120 - 150 talented Ugandans to be able to participate in the country's Oil and Gas sector, registered success as xxx registered and participated. The successful beneficiaries from the MOOC will be trained over the next four years to become production operators, maintenance, and inspection technicians for the Tilenga project. The training will be undertaken in partnership with the Uganda Petroleum Institute Kigumba (UPIK) followed by international training exposure at a TotalEnergies producing site.

Speaking during the Tilenga MOOC launch event held Kampala Serena Hotel on January 11th, Mr. Philippe Groueix, General Manager, TotalEnergies EP Uganda revealed that through the Tilenga Project, the company aims at enhancing the competences and capacities of Ugandan companies, Ugandan citizens and registered entities in oil and gas activities to encourage local participation.

"As a Truly Ugandan company, our national content strategy is aimed at maximizing the use of Ugandan expertise, goods and services. The Tilenga MOOC is one of such initiatives that will enhance the skills and knowledge of young talented Ugandans interested in participating in the oil and gas sector," Mr. Groueix said.

He also revealed that the program is part of TotalEnergies EP Uganda's National Content Strategy and initiatives.

The Tilenga MOOC was open to all Ugandans between the ages of 18 - 28 years with emphasis on people living within Tilenga Project areas. An A 'level (Uganda Advanced Certificate of Education) was the minimum education level requirement.

While speaking at the launch, Ms Peninah Aheebwa, the Director Technical Support Services, Petroleum Authority of Uganda (PAU), commended TotalEnergies EP for starting the Tilenga MOOC program because it fits within the overall national

content strategy which is designed to promote the participation of Ugandans and Ugandan companies in the oil and gas sector.

"The Authority supports programs that are designed to empower Ugandans to benefit from the opportunities in Uganda's the oil and gas sector, by giving them the right knowledge and skillset. The father of eight and 40 grandies has thirst for tree growing. He has planted various tree species from fruits and other species of woodlots on his 12 acre-piece of land.

At Ntakimanye home, one feels a fresh breath of life from the cool air blowing through the thick canopies formed out the different giant tree species in his home. The common tree species found in his home include Eucalyptus, Grevelia Robusta, Neem, Giant Lira. Others are Jack fruits, lemon, Mango, Citrus, guava among others.

And taking a stride of about a 20-meters from Ntakimanye's newly constructed home, one is also greeted with site of a nursery bed that sits on a 10metre by 5-meter with green-leafy seedlings.

To Ntakimanye, the nursery seedbed is like a vein that transport blood to the body to function. He explains that he started the nursery bed in 2019 but it crumbled later, until TotalEnergies came in to with support two years ago. "This is my life, I'm able to earn money daily from this. I established it with support from TotalEnergies through CIDI," he said.

The nursery bed has over 14,000 seedlings. The price of the seedlings ranges between sh1,000 to sh2,000. Ntakimanye customers are TotalEnergies' contractors and the local community in Buliisa.


"My customers are from within the locality, and some TotalEnergies' contractors," he says. Ntakimanye says his biggest setback has been dry spells and Covid-19, noting that during lockdown, he lost sh7.5m in seedlings after he failed to secure markets to sell them.

For the dry spells, he hopes one day his home will be connected to pipe water. "TotalEnergies repaired the broken borehole in our area to easy access to water. But it's my prayer that that our authority connects us to tape water," adding, "sometimes it's not easy to get water when other community members are also seeking to fetch water from the same source."

Ntakimanye tree journey
Ntakimanye love for trees dates back
to 1972 when he planted the first lots of
woodlots in Kasenyi village. "I started tree
planting in 1972 in Kasenyi. I was still a
little boy in Primary five, before I shifted
here, and I'm glad they are still there" said
Ntakimanye.

According to Ntakimanye it wasn't a bed of roses for him, noting he endured ridicules from his peers, but he remained firm. He says he has now become a village envy to those who rebuked him those days as everyone now look up to him for poles and other wood products. "I was called a clueless man who is out there to waste his land, but I can tell you the same people are now regretting. I'm reaping from the trees, I don't struggle for firewood, I have paid my children in schools, and all are in school. Courtesy of my trees." said Ntakimanye, emphasizing, "They now come to me to give them wood and things like poles, and with the support I received from TotalEnergies I can only rest when God calls me. I have taken it as a business now. In fact, let everyone embrace tree planting"
