TotalEnergies EP Uganda (COMPANY), in its capacity as Operator of Contract Area (CA) 1 and License Area (LA) 2, in conjunction with its Joint Venture partner(s), invites experienced and qualified companies/entities to express interest in the provision of Drill Pipe Swivel Equipment and Services for Tilenga CA-1 and LA-2 North Development Drilling Campaign in Uganda.

General Field Development Description:

The Tilenga oil and associated gas development is located in the Northern area of Lake Albert in Uganda and covers the fields in CA-1 block and the Northern part of LA-2 block (Tilenga Project). The major development surface facilities include the following:

- · Wellpads (31) and the upstream gathering network.
- The Industrial Area containing temporary facilities and the Central Processing Facility (CPF).
- The associated supporting infrastructure (camps, roads, aerodromes etc.).

Brief Description of the Scope of Services:

COMPANY intends to issue a future Call for Tender for Drill Pipe Swivel Services and Equipment to aid the running of lower completion equipment in shallow and highly deviated wells.

Following requirements to be demonstrated:

- Swivel technology and Torque and Drag Software with field proven experience.
- Availability of experienced field service personnel to support operations.
- Organisational, Technical, Financial, Health, Safety and Environmental (HSE) requirements to set-up and operate the above-mentioned services, compliant with industry and COMPANY standards.

COMPANY seeks to identify a company possessing or capable of providing Drill Pipe Swivel Equipment and services during the ongoing development drilling operations. The company/entities shall comply with COMPANY's technical requirements to perform the operations efficiently.

- Proven experience in provision of drill pipe swivel equipment and services for an international oil company or major operator.
